Methods of Instruction

The class will have a lecture, discussion, a demonstration, and then the student will practice manicuring and pedicuring.

- 5. Perform the different types of manicures.
- 6. Demonstrate the proper procedure for a pedicure.

- 8. Creating nail art by using what earth has to offer.

Absentee Policy

Students must maintain an 85% attendance or be on probation until the student complies. If This is not accomplished the student's grade will be lowered by one letter.
